ABSTRACT

It has been quite common to here that there have been delays in the project in the construction industry. If not all, but majority of construction projects has experience delay in trying to meet the date for the completion of projects. Due to this, delay has become one of the most common problems in the construction industry. In relation to this, many studies have been carried out to study the cause of delays in construction industries. Studies have also been carried out as how to find remedy to these delays, so that, construction projects can be completed on time. This will than help to save time and cost in the construction industry. The aim of this study is to identify the process and factors that courses delay in Accommodation and Works (A&W) Directorate and to propose a strategic action plan that can be taken by A&W Directorate in preventing further delays at the pre-tendering stage. The methodology adopted is through literature research, interviews and questionnaire surveys with the top management and staffs in the industries. Summated Rating or better known as Likert Scale will be used in presenting the data for the respondent to choose the best possible answer in data gathering. It will reflect the respondent's attitude towards the statement that will be tailored to look into the factors of delays that occurs in A&W Directorate. The data will be presented in the form of Bar Chart and Pie Chart. This study is confined to the delay at pre-tendering stage in A&W Directorate. The data gained from the analysis will be used to determine the seriousness of the problems and provide a solution to improve the delivery system in A&W. It is expected that the proposed strategic actions plan deduced at the end of this study will assist in reducing the delays at pre-tendering stage in A&W Directorate.
