2. Semua mahasiswa adalah diingatkan kepada lima (5) kesalahan yang dipandang **SERIOUS** oleh pihak Universiti seperti berikut:-

- i. **Terlibat dalam kegiatan penyalahgunaan dadah;**
- ii. **Merosakkan harta benda Universiti dengan sengaja (*vandalism*);**
- iii. **Bergaduh secara kumpulan (*gangsterism*);**
- iv. **Mencuri; dan**
- v. **Meniru dalam peperiksaan.**

3. Tindakan tatatertib akan dikenakan ke atas mana-mana mahasiswa yang ditangkap kerana kesalahan seperti di atas dan jika disabit kesalahan boleh dihukum mengikut peruntukan di bawah **Kaedah 48, Bahagian V, Tatacara Tatatertib, Kaedah-kaedah Universiti Teknologi Malaysia (Tatatertib Pelajar-pelajar) 1999** atau mana-mana peruntukan atau perundangan lain samada dalam kampus atau di luar kampus, yang boleh menyebabkan saudara/i dijatuhkan hukuman maksima **DIPECAT DARI UNIVERSITI.**

4. Pihak Universiti tidak teragak-agak untuk mengambil tindakan dan menjatuhkan hukuman maksima jika saudara/i didapati bersalah dalam melakukan kesalahan seperti di atas.

I would like to draw your attention to the above matter.

2. All students are reminded that the following five (5) offences are considered **SERIOUS** by the University:-

- i. **Involvement in drug abuse activities;**
- ii. **Vandalism of University property;**
- iii. **Involvement in gangsterism;**
- iv. **Theft; and**
- v. **Copying in examinations.**

3. Disciplinary action will be taken against any student who caught committing the above offences and if found guilty, the student may be penalized under the provision of **Rule 48, Part V, Disciplinary Procedure, Universiti Teknologi Malaysia (Discipline of Students) Rules 1999** or any provision or legislation whether in or outside the campus. If found guilty the student can be given the maximum penalty of **EXPLUSION FROM THE UNIVERSITY.**


4. The University will not hesitate to take action and to impose the maximum penalty if a student is found guilty of committing the above offences.


